President Gochenour called the March 13, 2025 Berkeley County Commission meeting to Order at 9:35 A.M.

Re: Items from the Public

Joshua Mongold from the Red Cross appeared before the Commission and read a Proclamation for Red Cross Month. President Gochenour advised Mr. Mongold that they couldn't take any action because it wasn't scheduled on their Agenda, but they would be happy to add it to next week's Agenda.

President Gochenour stated that a new hire recommendation was received from the Honorable Larry Hess, Assessor for Bobbi-Ann Foltz as a Personal Property Clerk with a hire date to be determined with an annual salary of \$35,360.

President Gochenour stated that a new hire recommendation was received from the Honorable Rob Blair, Sheriff for Dallas Plank as a Deputy Sheriff effective March 17, 2025 with an annual salary of \$54,188.

President Gochenour stated that a new hire recommendation was received from Tim Czaja, Community Corrections Director for James Kennard as a Drug Screening Tech effective April 1, 2025 with an annual salary of \$39,812.

Commissioner Hardy made a motion to approve the Consent Agenda for the March 13, 2025 Berkeley County Commission meeting. Vice President Catlett seconded the motion. The motion carried unanimously.

The Assessor's Office had nothing to present this week.

Re: Board Meeting Reports

Commissioner Boyd reported that he had no meetings this week.

Commissioner Hardy reported that he was unable to attend the Public Service Water District meeting, but did attend the Telmon board meeting.

Commissioner Whitacre reported that he did not have any meetings this week.

Vice President Catlett reported that he attended the Farmland Protection board meeting where George Miller resigned and will now have two vacancies on the board. He stated that they are planning their 25 anniversary celebration in June. Vice President Catlett stated that he and President Gochenour met with the Superintendent of Schools and it was a productive meeting. He also reported that he President Gochenour and Gary Wine, County Administrator met with Judge McLaughlin regarding the new court rooms in the old jail and he stated that they looked very impressive and the Judge is pleased and thanked her for her patience. Gary Wine also thanked Judge Delligatti for her patience as she was delayed moving into her office as well. Vice President Catlett thanked President Gochenour and Randy Lilly, Emergency Management Director for driving five hours down and back to deliver items from Berkeley County to the flood victims.

President Gochenour reported that he attempted to attend the LEPC meeting, but they had changed the time and he arrived early and spoke with Randy Lilly and was advised the Agenda was light so he didn't wait to attend. He reported that he met with the Superintendent of Schools along with Vice President Catlett regarding the safety of the schools and also attended the Development Authority meeting where they continue to have a lot of activity. President Gochenour stated that he and Gary Wine have a Zoom call today with Jefferson County who are having issues with their DRC and has a Fireboard meeting tonight. President Gochenour thanked everyone involved on the progress of the old jail for the courts and gave a special thanks to Gary Wine for all his efforts.

Re: Board and Commission Vacancies

President Gochenour stated that a new application was received from Garland Elliott, Jr. for the Farmland Protection board and requested to have him scheduled for an interview. He also stated that a letter of resignation was received from George Miller from the Farmland Protection board.

Re: Board and Commission Interview Betsy Plumer – Candidate – Farmland Protection Board

Re: Gary Wine, County Administrator Adoption of FY2025-26 Budget Health Insurance Renewals

Gary Wine, County Administrator reviewed the Budget for FY2025-26 with no increase in the Levy rate.

President Gochenour stated that he would like to have a discussion before adopting the budget and wanted to get the consensus of the Commission on raising the levy from \$13.39 to \$13.92 for public safety to be able to hire five (5) more deputies. He stated that the when the Sheriff presented his budget he stated that he is at the half the staff of Deputies needed. A discussion followed by the Commission. President Gochenour thanked everyone for their input and discussion and asked to table the adoption of the budget until next week.

Vice President Catlett made a motion to table the Adoption of the FY2025-2026 budget until next week. Commissioner Boyd seconded the motion. Commissioner Hardy opposed the motion. The motion carried four to one.

Mr. Wine stated that he was looking for consensus of the health insurance renewals. He stated that our current health care provider has presented us with a 25% increase and he stated that he would like to put our health care coverage on the street to see what else is available. Mr. Wine stated that he would continue to negotiate with our current provider, but would like the consensus of the Commission to put an RFP out on the street to see what coverages are available. The consensus of the Commission was to put an RFP out on the street.

Re: Items from the Public

Shawn Wilt appeared before the Commission and asked if the Commission had ever had a full complete audit in the past 10-15 years. The Commission advised that we were statutorily required by the State Auditor's Office to be audited every year by an independent auditor. Mr. Wilt wanted to see a forensic audit done.

Commissioner Hardy made a motion to go into executive session at 10:30 A.M. for pending legal matters. Commissioner Boyd seconded the motion. The motion carried unanimously.

President Gochenour declared the Commission out of executive session at 10:50 A.M.
