Commissioner Moffitt, seconded the motion. President Buck, called for any discussion. With there being no discussion. President Buck called for a vote. The vote was unanimous and the motion carried. - 6. **Budget Update (Informational)** Current FY 2024-2025 Budget & Proposed 2025-2026 Budget. Mr. Alderton gave a summary of the current civil service budget, As represented on the County Clerk's financial report dated March 18, 2025 the following information was conveyed. - (1) Current Budget Report: We are still awaiting two (2) invoices in the amount of \$710.96 and \$210.00 from LocaliQ Advertising. The \$710.96 is to cover the cost of Advertisements in The Herald Mail (Hagerstown, MD), Waynesboro Record Herald (Waynesboro, PA) & Chambersburg Public Opinion (Chambersburg, PA). The amount of \$210.00 is to cover the cost associated with Online Job Boards advertising such as InDeed, ZipRecruiter, Glassdoor, etc.
- (2) Mr. Alderton presented the below numbers associated with the Online Job Boards:

Reporting Lownload Report → 1 1,899 Total Jobs Posted In the last 30 days 1,899 average / job Download Report → 171 Total Clicks 171 average / job

- (3) Proposed Budget for FY 2025-2026. Mr. Alderton updated the commissioners, by informing them of the below information:
 - (a) On Thursday, February 26, 2025 the County Commission met to begin working on the County Budget for 2025-2026.
 - (b) Initially, our Training/Education Line item of \$16,500.00, which was for our tests, was eliminated. The County Commissioners, were of the belief, this related to the purchase of books, not tests. The commissioners were adamant; they were not going to buy books. County Clerk Petrucci, heard this, came, and briefed me. Then we both went before the County Commissioners to provide clarification.
 - (c) Mr. Alderton, explained, the cost of \$16,500.00 was for the purchase of tests (First and Second Line Supervisor), a Study Guide, and a portion of the money was to customize the tests relating to local policy & procedures, and potentially state code.
 - (d) Additionally, it was further explained we knew the county clerk's budget could not afford to purchase the suggested set of five (5) "books" for every deputy who would be eligible to test.
 - **NOTE**: Our initial budget presentation to the County Commissioners can be viewed by going to https://www.youtube.com/watch?v=gFZhTGohhlA
 - (e) On Thursday, March 6, 2025 the County Commission announced the Civil Service Budget for 2025 2026 would be \$22,500.00. Thus eliminating the Training/Documentation Line item of \$16, 500.00. This is what was submitted for the Promotional Tests with Stanard & Associates.

- (f) Commissioner Moffitt asked for clarification on how many books would be needed to test all the way through the ranks. Mr. Alderton replied it would depend on how many people were testing. Clarification was given by Commissioner Moffitt, using the example of one (1) person. Commissioner Dopson replied by stating two (2) sets of five (5) books. Commissioner Moffitt's point he was making was maybe we could look at something like a checkout system for these books buy three sets of each of the five sets allow these people to check them out and utilize them.
- (g) Commissioner Dopson, added it's a moot point now because they (County Commissioners) didn't approve the budget which was to get the test questions and sign with the company which was either they misunderstood or they just at the end didn't care. So the money was never for the books. The money was for the test and to get our own questions added to the test, based on policy and local rules. That's what the budget was for.
- (h) The County Clerk is not in favor of utilizing any funds out of this year's 2024-2025 budget to fund any tests material with Stanard & Associates. His concern is we may not be able to continue the efforts in 2025-2026 without the adequate funding we requested.
- (i) President Buck, added he thinks, it looks pretty much like the issue is dead for this year he thinks the question is what do we start doing so we do something better next year? Commissioner Moffitt agreed and added, he thinks it is dead for this year because the budget's already been approved. But we've got it and we now know we obviously didn't do something right and approach this properly. Because it's obvious we can see how much we need this and the sheriff wants it. You know the association wants it. These are all things that'll do nothing but better the Berkeley County Sheriff's Department and the people that we bring on board and the people that we promote. So you know we have to somehow sell that next year to get budget for this type of an endeavor.
- (j) Mr. Alderton replied by saying the County Commissioners thought process was County Clerk has money that he can move around. In talking with the county clerk if he moves it from someplace else to us that's taking away from that other organization. It could be voter registration it could be finance department so somebody within his area is going to get cut. Mr. Alderton believes a reasonable approach is to go for one rank first and not going for two. Maybe next year we say we take a look at the promotion of using a new test system for just the rank of Corporal & Sergeant, since it's the same test. Then the year after we submit for the new test system for the rank of Lieutenants/Captains. Mr. Alderton went on to suggested allowing the stakeholder, such as the Sheriff weigh in on which ranks he would like to see new tests offered first. Commissioner Moffitt agree and thought this was a good idea.
- (k) Commissioner Moffitt went on to say. You're going from a corporal and then from a corporal to a sergeant. So at least, if we get the books and the stuff these guys have all this stuff then they're going to get a lot of the very important stuff at the beginning. Then if we can prove within a couple of years how beneficial this is you get better

candidates. You'll get better results, better statistics. Then we can say, we can relate it back to this and then maybe

get the funding to go to the next level because he (Commissioner Moffitt) really think that's going to add a lot of value for you (the Deputies & Sheriff). By giving them this information allowing them to do study.

- (l) Commissioner Dopson spoke up by stating, it's not something we're going to solve tonight. He suggested the issue/subject be tabled for tonight.
- (m) Commissioner Moffitt stated, that we have sort of an idea now to cut it in half and then we also have \$10,000 that we never use that we could use. We've never needed it before and we have a lawyer on the commission. Commissioner Dopson stated he (President Buck) can't represent the Commission. Chief Young addressed the commissioners by adding 2010 would prove all incorrect, as he was one of the initiators of a legal suit and that bill went up \$40,000 to \$50,000 if he wasn't mistaken. Commissioner Moffitt commented he appreciated knowing that, as he was not aware of the money expended in the past.
- (n) President Buck stated we would have a discussion next month again. For now, we'll move onto Old Business.

7. Old Business:

- a. **Issue 2024-0003.** Investigating Test Providers for Deputy Sheriff Promotional Examination Services. Mr. Alderton didn't have any additional information to provide. As it was addressed under the budget update.
- (1) Under the Budget update Discussion Commissioner Dopson, made the recommendation to table this issue for now. However, no formal motion was made to table the issue.

- b. **Issue 2024-0013.** Open Hire Process IAW Current Rules & Regulation. Commissioner Dopson, conveyed:
- (1) The rules went out on March 10th to everybody to review. We're requesting any questions or concerns with anything in there by April 10th. Then we'll answer those back. All questions or comments are to be sent to Mr. Alderton.
- (2) Hopefully we can get those approved at our April meeting. Some corrections or suggestions came in from Mr. Mauzy. President Buck, inquired if anything else had been received so far. Mr. Alderton replied, not at this point in time. He added, we've only received one (1) email with any updates. Mr. Mauzy originally suggested deleting the footnotes. But when asked why, he didn't realize they were for footnotes and he said "No those are good to keep in there."
- (3) We're waiting to hear back from the Sheriff and the Deputy Sheriff's Association on what they want to see revised. President Buck inquired, what's our process going forward? Commissioner Dopson replied, we're waiting for feedback and input then we'll consider

all those and any changes in the commission or the committee and bring it back here. If there are a lot of changes of course we may not make April meeting for approval.

(4) One of the topics for discussion in relation to the rules and regulation involves accepting applicants up to the start of the physical agility testing. This is preferred by the Sheriff and his leadership team. Mr. Alderton, reminded the sheriff if this is something to be considered to ensure it is written in the response back to the Rules & Regulations Committee, and sent to him by April 9th.

- c. **Issue 2024-0029**. Request for New Open Hire Physical Agility & Written Examination. RE: **December 14, 2024 Test.** Mr. Alderton provided the following summary:
- (1) As of March 18, 2025, Mr. Alderton was contacted by Ms. Brandy Sullivan of the Sheriff's Office inquiring when he could swear Applicant Plank in as Deputy Sheriff.
- (2) Applicant Dallas Plank's name was submitted to the County Commission for hire, with a start/hire date of Monday, March 17, 2025.
- (3) This action was approved by the County Commission at their meeting held on, Thursday, March 13, 2025.
- (4) As of Wednesday, March 19, 2025, the Civil Service Commission has not received a letter from the Sheriff or Chief's stating Applicant Plank meets all the requirements in West Virginia Code or the Rules & Regulations. Mr. Alderton briefed, the Sheriff's Office have a verbal that he's passed all of the medical requirements. However, they're awaiting the signature of a second doctor, as required by West Virginia State Code (§7-14-9)
- (5) Ms. Brandy Sullivan informed the Commission, the reason they do not have the letter is because of the hang-ups they're trying to overcome with Valley Health. They're not able to get results. Until multiple doctors sign off on Applicant Plank. He has completed all of his exam. Ms. Sullivan went on to state they've been told that he's passed everything and it's been over a week and they still do not have a second doctor to sign off on everything. This is unfortunate that we're having to deal with this but unfortunately we have not located anywhere else that can do all of the testing.
- (6) As of Wednesday, March 19, 2025, Mr. Alderton reached out to Sheriff Blair and Chief Young to ascertain the status of the remaining applicant, Stephen Moreland. During the conversation with Sheriff Blair, he indicated, he is recommending applicant Moreland be removed/stricken from the Eligibility List. He further directed me to Chief Young to obtain the letter of request to have him removed/stricken.
 - (7) Chief Young sent me the letter at 10:45 AM, March 19, 2025.
- (8) A Certified Letter of notification has been prepared, for Applicant Moreland. The certified letter states, Applicant Moreland has until 5:00 PM on Thursday, March 27, to respond if he desires to have a Public Hearing or wants to decline a Public Hearing.

- (9) Mr. Alderton made a recommendation to make a motion, should he want a Public Hearing; the date will be Wednesday, April 17, 2025, at 6:15 PM here providing the Commission Chambers are available. If unavailable, we could hold the hearing across the hall in the multi-purpose room. Only drawback there is the public hearing cannot be streamed.
- (10) Mr. Alderton reminded everyone, the eligibility list from the December 14, 2024 test date will need to be exhausted, before the commission can provide the Sheriff with the Top three (3) or in this case four (4) scorer's from or March 8, 2025 examination.

Commissioner Dopson made a motion to hold a Public Hearing to have applicant Stephen Moreland removed/stricken as requested by Sheriff Blair, On Wednesday, April 17, 2025. In the County Commission chambers, at 6:15 PM. Commissioner Moffitt seconded the motion. President Buck called for further discussion. There being none, he called for a vote. The vote was unanimous on accepting the motion as stated.

Currently, the Sheriff's Office has five (5) openings.

This was given an Issue Number of 2025 - 0007.

- d. **Issue 2024-0032.** Request for New Open Hire Physical Agility & Written Examination. **RE March 2025.** Mr. Alderton provided the following information:
- (1) This resulted in 14 (14) applicants being eligible to test. Out of the fourteen (14), we recieved notice from four (4) applicants, that they would not be able to attend the testing on March 8, 2025. This left a total of nine (9) applicants eligible to test. All nine (9) did report for testing on March 8, 2025. Out of the nine (9), only seven (7) were required to undergo the physical agility test, as the other two (2) were previously/currently certified law enforment officers. All seven (7) passed the physical agility test. Commissioner Moffitt served as the test proctor for the physical agility test. Which was conducted at Martinsburg High School Football Field.
- (2) An Open Entry Entry Level Physical Agility & Written Examination was held on Saturday, March 8, 2025.
- (3) Upon completion of the physical agility testing, we transitioned to the Sheriff's Office for the 84 question, two (2) hour Written Examination. The examination commenced at 10:12 AM. The first applicant finished the exam at 11:29 AM and the last applicant finished the exam at 12:02 PM, which was ahead of the cut-off time of 12:12 PM. President Buck served as test proctor for this event
- (4) The test materials were mailed back to the West Virginia Division of Personnel, on Monday, March 10, 2025, at a cost of \$14.10.
- (5) We recieved the test scores from WVDOP via email on Thursday, March 13, 2025, at 8:42 AM. All nine (9) did pass the written examination.

(6) A letter has not been provided to Sheriff Blair, relating to the top three (3) names/scorers. As the Eligibility List from the December 14, 2025 has not been exhausted.

- e. Issue 2025 0001, Annual Report for Calendar Year 2024. §7-14-6 Powers and **Duties**. Mr. Alderton reported the 2024 Annual Report is now complete. Mr. Alderton provided the following update:
 - (1) As a reminder... IAW the West Virginia State Code it states...
- (6) Make an annual report to the county court and sheriff showing its own actions, its rules and regulations, including all exceptions thereto in force, and the practical effects thereof, and any suggestions it may have for the more effectual accomplishment of the purposes of this article. Such report shall be available for public inspection five days after it shall have been delivered to the county court and sheriff.
- (2) Mr. Alderton urged the commissioners to approve the Berkeley County Deputy Sheriff Civil Service 2024 Annual Report.
 - (3) Mr. Alderton went onto to request two (2) motions be made.
- (a) One, to accept the Berkeley County Deputy Sheriff Civil Service 2024 Annual Report, as Written. Commissioner Moffitt made the motion to accept the Berkeley County Deputy Sheriff Civil Service 2024 Annual Report, as written. Seconded by Commissioner Dopson. President Buck called for any further discussion. There was none, so a vote was called for by President Buck. The vote was unanimous, in favor of the Berkeley County Deputy Sheriff Civil Service 2024 Annual Report, approved as written.
- (b) Second, to maintain the Berkeley County Deputy Sheriff Civil Service 2024 Annual Report, Civil Service Office, Suite 103-5 for viewing, and Post it to the County Clerk's Web Page for Civil Service. Commissioner Moffitt made the motion for it to be viewed in the Civil Service Office, Suite 103-5 and post it to the County Clerk's Web Page for Civil Service. Seconded by Commissioner Dopson. President Buck called for any further discussion. There was none, so a vote was called for by President Buck. The vote was unanimous, in favor of it being maintained in the Civil Service Office and posted to the County Clerk's Web Page. (CLOSED)
- e. **Issue 2025 0003**. Promotional Exam Request for Rank of Sergeant due to Sergeant Heagy Demotion (Voluntary) Request, which created the vacancy as of July 1, 2024. Mr. Alderton reported he has two (2) letters. One dated February 18, 2025 and the other dated March 17, 2025.
 - (1) The letter of February 18, 2025 relates to a test for Sergeant.
 - (2) The letter on March 17, 2025 is referring to a test for Sergeant and Corporal.

- (3) Chief Young then verbally rescinded his request for a test for Corporal. Stating a Corporal test is not needed. It was not needed due to when Sergeant Heagy stepped down that placed the Sheriff's Department heavy by one Corporal. Therefor a Corporal test is not needed.
- (4) Mr. Alderton brought up the issue of an Addendum (see Attachment 3) to Current (9-15-2021) Rules & Regulations, Article III, Promotions, Section II Eligibility (§7-14-13) For the records and tracking, this was given **Issue Number 2025 0006** and titled Addendum to Current (9-15-2021) Rules & Regulations, Article III, Promotions, Section II Eligibility (§7-14-13). **NOTE**: The reason it was brought up at this point, is due to it directly affecting this issue.
- (a) Discussion evolved around the Addendum stating how the process would work if approved. The Addendum was crafted, due to the way the current Rules and Regulations are writen, Corporal Chronister would be the only one ever to be able to test for the vacancy created on July 1, 2024.
 - (b) Commissioner Dopson, recused from further discussion.
- (c) President Buck asked, so in the event that we do this that we make this adjustment what becomes the vacancy date. Meaning, the vacancy date is from the date of July 1 is that going to be the vacancy date of the next officer to step. Mr. Alderton replied, he does not see it that way. Because the officer that is now the officer that is now eligible his date of eligibility wasn't until March 17th. Therefore, Mr. Alderton thinks that then becomes the new date to go off of.
- (d) Lt Christian stepped up to the microphone requesting clarification. He asked ... are you saying that we have a person that's eligible as of Monday for the test but we're not we're going to wait till April 1st to send a letter in order to do the test? Mr. Alderton replied yes.
- (e) Mr. Wilson then stepped up and stated... you have a person in this case here you're going by the first of the month because that's when the original vacancy date was. But let's say on the 17th of this month you have a person becomes eligible he (Sheriff) needs to send you all a letter right now, saying I have a person eligible on the 17th and then that way that person and then you can ask is there anybody else eligible which would be the one person in this case that that turned it down you should get two names. You can start, you don't have to wait till the next month. Commissioner Dopson, added so in our rules meeting we discussed that if we do that there's a possibility to manipulate the date. Because that person who turned it down could at any time say okay I want it now. Mr. Wilson responded, that's true. Commissioner Dopson, went on to say, you got to have a date and time unless maybe he's got a buddy that's like not eligible till a certain date. Mr. Wilson stated I got to tell you in the conversations we had then I misunderstood what you (Commissioner Dopson) were coming at. Because when a person becomes eligible that's the date you're going by. You're doing every 30 days because you're checking in with him to see if he had anyone else come available. You could have said it every two weeks you could have said it every week yeah but we didn't you said that's right you said it every 30 days when he has a man who becomes eligible on this date I think that you would be remiss as a commission by not going ahead and starting the procedures because he's eligible. Why are we going to wait and if you take this situation away and you go with just standard promotions. He (Sheriff) should be notifying you immediately when a person becomes eligible let's say that we didn't have that vacancy from back in July let's say that you had a

vacancy that just came up on March 17 March. He (Sheriff) has a man that's eligible he should be sending you a letter and you should be moving forward with that. In this case here you should move forward if he sends you a letter. You should move forward then you don't have to wait till one April he's done notified you. He's got a man that's eligible you can look at that and say "Okay do you have anybody else is eligible?" In this case he would have two you know you're going to contact that other person or contact them both and say "You're eligible do you want to test. Everybody's anticipating only one person's going to do that and you move forward you don't have to wait till one April.

- (f) President Buck recognized people were getting lined up at the podium and a motion had not been made yet. He acknowledged there would be time for discussion, if a motion is made to adopt. Therefore, President Buck wanted to move back to procedure.
- (g) President Buck wanted to seek an understanding from Mr. Alderton by saying...you have suggested this amendment to the rules. Additionally, if there, there is a motion, we make and we adopt this... is there a motion, any motion regarding this
- (h) Commissioner Dopson, again stated he was recusing. President Buck acknowledged Commissioner Dopson recusing himself.
- (i) Commissioner Moffitt, made a motion to adopt it (Addendum) President Buck, seconded the motion. Then opened it up for further discussion, since there was a motion and a second.
- (j) Chief Young stepped up to the podium. He stated he and others were under the impression that tonight is the night we discuss the issues we have we weren't told to send them in or we would have. Commission Dopson, clarified it was in the email sent to the Sheriff & Deputy Sheriff Association, for them to send their suggestion-recommendations to John (Mr. Alderton) and we (Rules Committee) would address all the questions at one time.
- (k) Lt Christian again stepped up to the podium and inquired ... since we're still operating under the same rules that we currently have in place and these aren't adopted and that every 30 days thing is not adopted why would we hold up this promotion test and not go ahead and start it immediately? Commissioner Dopson, added, because under the current rules nobody could ever test for that position except Corporal Chronister, he's the only one that would be eligible to ever test for that vacancy.
- (l) President Buck stated... We've got an addendum here, we've got a motion to adopt it and we're in a discussion period. He added, he thought the idea was good. The idea was to move this forward and to break the log jam. So we cleared the list and we can move forward, but with the discussion in room here. We're not ready to adopt this. There's just too many questions for adoption. President Buck acknowledged Commissioner Dopson recused but stated Commissioner Dopson can discuss rules. Commissioner Dopson stated, doesn't know how we ever move forward if we don't adopt something. He agrees, some procedure for allowing a new newly eligible person to test. Or if someone would change their mind or any number of things that kept a person him from taking the position; death in the family, family issues. Commissioner Dopson felt it was the thought among the committee was that if at any point after that he wanted to accept the promotion he could test again. We were trying to get some structure around it.

(m) President Buck went onto state...we've got a motion it's been seconded, it's time for a vote. All in favor of adopting this amendment as proposed say yes. President Buck and Commissioner Moffitt voted in favor of adopting the Addendum Commissioner Dopson Abstained due to his recusal. The motion passed, and is therefore adopted on March 19, 2025. President Buck added, nothing precludes the Rules & Regulations Committee from tweaking it in their revision.

ADDENDUM TO THE RULES & REGULATIONS OF THE BERKELEY COUNTY DEPUTY SHERIFF CIVIL SERVICE COMMISSION

Adopted: Wednesday, March 19, 2025

<u>NOTE</u>: The below language supersedes the current language as written in the current Rules & Regulation, adopted on September 15, 2021, titled Article III Promotions, Section II – Eligibility (§7-14-13)

Section II – Eligibility (§7-14-13)

1. Eligibility for Promotion:

No person shall be eligible for promotion from the lower grade to the next higher grade until they have completed at least two years of continuous service in the next lower grade. Eligibility for the two-year service requirement shall be determined as of the date of the vacancy for which the promotion is being made.

2. Process in the Absence of Eligible Candidates:

If there are no eligible candidates for promotion, or if the only eligible candidate declines, the following procedures shall be followed until at least one eligible candidate is identified and accepts the promotion:

a. No Eligible Candidates

- (1) Every 30 days from the date of the vacancy, the BCDSCSC shall formally request a written response from the Sheriff regarding the availability of eligible candidates.
- (2) The Sheriff shall provide a written response indicating whether any candidates have become eligible.
- (3) This process shall continue in 30-day intervals until an eligible candidate exists and agrees to participate in the promotional examination.

b. Declination of the Promotional Opportunity

- (1) Any deputy sheriff who declines to take the written examination or declines the promotion shall submit a written statement to the BCDSCSC within five (5) days of notification of eligibility or within five (5) days after passing the written examination.
- (2) Upon receiving such notice, the BCDSCSC shall continue to request eligibility updates from the Sheriff every 30 days, following the same procedures outlined above.
- (3) Each deputy who declines a promotion must do so in writing.

(4) During each 30-day review, the previously eligible deputy who declined shall be given another opportunity to accept the promotion and take the examination. If they reconsider, a new written examination shall be administered.

3. Promotion Criteria

Promotions shall be determined based on merit and fitness, as assessed by the Civil Service Commission, and upon the superior qualifications of the candidates, as demonstrated by their previous service and experience. The following criteria shall be used:

- a. Qualifications Based on previous service (performance appraisals) and experience (seniority).
- b. Merit Assessed through a competitive written examination provided by the Civil Service Commission.
- c. Fitness Determined through a medical examination.

4. Legal Precedents

- a. Civil Action 11-C92 affirms that the two-year service requirement must be continuous and immediately preceding the vacancy. The Commission is required to certify deputies for promotion in accordance with this interpretation.
- b Mangus v. Ashley, 199 W. Va. 651, 487 S.E.2d 309 (1997) establishes that promotions must be based on (1) qualifications as demonstrated by previous service and experience and (2) merit and fitness as determined by competitive examinations.
