Re: Call to Order

President Gochenour called the April 24, 2025 Berkeley County Commission Meeting to Order at 9:35 A.M.

Re: Items from the Public

John Kidwell appeared before the Commission and asked the Commission to slow the building progress down in Berkeley County as the hospitals and schools and roads maintenance could not keep up. President Gochenour stated that Berkeley County has no authority over WVU East and they have not invested in Berkeley County, but they will be in the near future. Commissioner Hardy advised Mr. Kidwell to reach out to his local Delegates and Legislators as the Commission has no oversight on the roads and legally cannot stop the growth.

John Christiansen, President of the Eastern Panhandle Labor Counsel appeared before the Commission and stated that April 28, 2025 was Worker's Memorial Day to remember those who have lost their lives and requested a moment of silence.

Re: Agenda

Commissioner Hardy made a motion to approve the Agenda for the April 24, 2025 Berkeley County Commission meeting. Commissioner Boyd seconded the motion. The motion carried unanimously.

2. Internal Budget Revisions

Gary Wine, County Administrator reviewed the two (2) internal budget revisions received.

3. Changes in Status

President Gochenour stated that a new hire recommendation was received from The Honorable Sheriff Rob Blair for Lia Darling as a Tax Office Director effective May 19, 2025 with an annual salary of \$95,000.

President Gochenour stated that a new hire recommendation was received from Tim Czaja, Community Corrections Director for Lesie Musgrove as a Peer Recovery Coach effective April 28, 2025 with an annual salary of \$43,135.

President Gochenour stated that a new hire recommendation was received from Mike Laing, Chief Court Marshal for James McBee as a Deputy Marshal I effective May 16, 2025 with an annual salary of \$39,017.

President Gochenour stated that a letter of resignation was received from Mike Laing, Chief Court Marshal for Rodney Kreps, Deputy Marshal effective May 1, 2025.

4. Approval of Minutes

President Gochenour stated that this was a state and local cybersecurity grant three (3) year program for a total request of \$31,756 with no grant match.

He also reported that he would be attending the Ambulance Authority meeting tonight where it would be Brandon Truman's first meeting as Director.

President Gochenour stated that he along with the Vice President Catlett had lunch with Senator Helton from Fayette County and felt that Senator Helton would be very supportive. He also reported that he and Anthony Delligatti, Legal Director participated in a zoom call regarding House Bill 2014 and will appear on WRNR radio program tomorrow along with Vice President Catlett.
