President Gochenour called the May 1, 2025 Berkeley County Commission meeting to Order at 9:35 A.M.

Gary Wine, County Administrator reviewed the one (1) internal budget revision received.

President Gochenour stated that a new hire recommendation was received from Jennifer Swisher, Emergency Communications Director for Calese LeCompte as a Telecommunicator I effective May 19, 2025 with an annual salary of \$50,341.

President Gochenour stated that a change in status was received from Tim Czjaj, Community Corrections Director for Taylor Paker, Peer Recovery Coach for a temporary job change to Community Service Coordinator effective May 1, 2025 with a salary change from \$43,135 to \$50,676.

President Gochenour stated that a change in status was received from Mike Laing, Chief Court Marshal for William Parks, Deputy Court Marshal for a step increase for years of service effective May 1, 2025 with an annual salary increase from \$39,017 to \$40,678.

President Gochenour stated that a letter of resignation was received from The Honorable Rob Blair from Deputy Derek Walker effective May 4, 2025.

President Gochenour stated that a letter of resignation was received from Chase Winebrenner, IT Manager from Kaitlyn Mauck, GIS Specialist effective April 28, 2025.

Re: Motion to Approve the Consent Agenda

Commissioner Whitacre made a motion to approve the Consent Agenda. Commissioner Boyd seconded the motion. The motion carried unanimously.

Re: Correction of Assessment Logs, Apportionment of Assessments, Deconsolidation and Consolidation of Properties Applications – Assessor's Office

The Assessor's Office had nothing to present this week.

Re: Board Meeting Reports

Commissioner Boyd reported that he attended the Museum board meeting stating that board hopes to get the RFQ out for the museum drawings for the next month's meeting. He also reported that they are working on their website and voted to join the AASLH which is a group of museums that help each other to track artifacts. Commissioner Boyd reported that the consensus of the board was to use the storage space at Baltimore Street and thanked the Commission for the space. Commissioner Boyd reported that he attended the CVB meeting and reported that the hotel/motel taxes were down slightly from last year, but Air B & B's are up and this appears to be nationwide. He reported that the Berkeley and Jeferson County CVB's have teamed up with a PR group from Atlanta, GA. Commissioner Boyd reported that there was a lot going on with the film industry and the CVB has put together a committee to work on upcoming films with the most recent film in Berkeley County being wrapped up. He also reported that the CVB is working on a large GEO Cashing event in Woodstock for the end of May.

Commissioner Hardy reported that he attended the Public Service Water District board meeting where it was a standard meeting and discussed the upcoming budget and are in good standing. He stated that on July 1, 2025 there would be a 23.5% increase that had been built into the five year plan. Commissioner Hardy stated that a final decision was made on companies building the new towers. Commissioner Hardy stated that he continues to receive calls from constituents regarding the traffic issues from the CMC project . President Gochenour thanked CMC for being conscientious of the traffic issues and their employees parking their cars and being bussed to the plant.

Commissioner Whitacre reported that he participated in Health Care proposal interviews with the staff on Tuesday.

Vice President Catlett reported that he attended the Ambulance Authority board meeting and commended them on hiring a firm to do an internal study of the Ambulance Authority. He also stated that he attended the Stefanie Pierson Championship for Youth dinner at the Martinsburg Boys & Girls Club.

President Gochenour reported that he attended the Historic Landmarks Commission meeting via phone conference and reported that they were working on a grant from the Arts, History and Culture for the study of a cemetery they believe that exist in the rear of the Morgan Cabin and mortar that has been discovered on the property that they believe to be dating back to the 1600's. President Gochenour reported that he attended the ribbon cutting ceremony along with Commissioner Whitacre at WVU East which will be a \$240,000 million investment by WVU East. He also reported that he attended the ground breaking ceremony for the Mountain Ridge Primary school. President Gochenour stated that he spoke at the Chamber of Commerce breakfast this morning and thanked Randy Lewis for his leadership.

Vice President Catlett made a motion to award the bid for the Animal Control Pistols to Atlantic Tactical, Inc. in the low bid amount of \$13,245.20. Commissioner Whitacre seconded the motion. The motion carried unanimously.

Chief Burnett reviewed the RFP for the Incinerator recommending the bid be awarded to Mountain State Equipment in the low bid amount of \$45,900 and stated that this was under budget and being paid for with grant funding from the WV First Foundation grant.

Chief Burnett reviewed the RFP for the Interdiction Tool Kit recommending the bid be awarded to Relentless LLC Desert Snow in the low bid amount of \$16,796.50 which was under budget and would be paid for with WV First Foundation grant funding.

Commissioner Boyd made a motion to award the bid for the Interdiction Tool Kit to Relentless LLC Dester Storm in the low bid amount of \$16,796.50. Vice President Catlett seconded the motion. The motion carried unanimously.

Chief Burnette reviewed the RFP for the Raman Spectrometer recommending the bid be awarded to Rigaku Analytical Services in the low bid amount of \$54,320.00 which was under budget and would be paid for with the WV First Foundation grant funding.

Vice President Catlett made a motion to award the bid for the Raman Spectrometer to Rigaku Analytical Services in the low bid amount of \$54,320.00. Commissioner Whitacre seconded the motion. The motion carried unanimously.

Chief Burdette requested to use the remaining grant funding for a concrete pad for the incinerator. Mr. Wine stated that he would need to check with the WV First Foundation to see if the funds could be repurposed for this project.
