- (a) Postage. This fiscal year we are seeing an increase from \$750.00 to \$1,500.00. Our current obligation rate stands at 2.1%. This is a result of \$31.59 being encumbered for the purposes of mailing back Corporal test materials to WVDOP. We will have approximately, the same amount of \$32.00 \$35.00 to mail back to WVDOP, the test materials for our Corporal test being offered this Friday, July 18, 2025.
- (b) Advertisement & Publication. This fiscal year we are seeing an increase from \$5,000.00 to \$10,700.00. Our current obligation rate stands at 0%. However, our outstanding invoices include: \$710.96 for LocalIQ Newspaper ad (8 Run in each of 3 newspapers Herald Mail, Chambersburg Public Opinion and Waynesboro), \$210.00 for Online Job Board Advertisements and \$455.00 for the Journal add relating to our Open Hire advertisement, which ran on Saturday, July 12, 2025.

NOTE: Local IQ designed and created the "Hiring" graphic as part of the \$710.96. Additionally, Mr. Matt Umstead, Director of Strategic Planning & Communication for Berkeley County created a Hiring graphic to be used on social media.

Mr. Alderton provided an update in regards to when the hiring ads ran and in which publication. He also provided the Commissioners with sample tear sheets of those ads. The ads thus far have run for 2 days in all three (3) of the newspapers -7/9 & 7/13 in Chambersburg, PA, 7/9 & 7/12 in the Hagerstown, MD & in the Waynesboro, PA newspapers. The ads will run 6 more days in each paper -7/16, 7/20, 7/23, 7/27, 7/30 & 8/3 in Chambersburg, PA & Hagerstown, MD and 7/16, 7/19, 7/23, 7/26, 7/30 & 8/2 in Waynesboro, PA newspaper.

Mr. Alderton also provided the statistics related to the online Job Board Ads. The number 0 applied, is due to us directing people to the Berkeley County Website to apply. Since we're doing that it cannot be tracked, by the Online Job Boards.

- (c) Training/Education. This is a New Line Item. This amount reflects \$16,500.00 the original amount we were briefed that we would not be receiving earlier in the year. Current Obligation rate is at 0 %.
- (d) Professional Services. This Line Item reflects an amount of \$10,000.00. Current Obligation rate spent is listed as 0 % Obligation. (INFORMATIONAL)

6. Old Business:

- a. **Issue 2024-0032**. Request for New Open Hire Physical Agility & Written Examination. RE: March 2025. Mr. Alderton briefed the following summary of where this issue currently stands.
- (1) As result of the Commissions motions and unanimous votes last month two (2) (Roy & Brown), applicants were removed from the Eligibility List. A revised Eligibility List was provided to Sheriff Blair on June 19, 2025. The revised letter contained the names of Applicants; Cressman and VanDevander.
- (2) On June 25, 2025 Chief Young informed our office, Applicant VanDevander submitted an email to Sergeant Funk on June 24, 2025, that he was withdrawing his name for consideration.
- (3) This action leaves only one (1) applicant on the eligibility list, which is Applicant Cressman.
- (4) This item will remain open until the current eligibility list is completely exhausted. Applicant Cressman is the remaining applicant from the March 8, 2025 Open Entry Examination.

 (OPEN)
- b. **Issue 2025-0020**, Request for Promotional Examination for the Rank of Corporal, as Result of the Retirement of Captain Hall. The Eligibility date is April 19, 2025.
- (1) A promotional examination for the rank of Corporal was conducted on Friday, May 30, 2025, at 9:00 AM & Monday, June 2, 2025, at 9:00 AM.
 - "Second oldest county in Mest Virginia"

- (2) Fifteen (15) deputies sat for the test on May 30th. While two (2) sat for the test on June 2nd. Therefore a total of seventeen (17) deputies out of twenty (29) deputies eligible to test actually tested. This equates to 58.62 % who tested for the rank of Corporal. Both examinations were held in the training/classroom of the Berkeley County Sheriff's Office.
- (3) On Thursday, June 26, 2025 Chief Young provided Civil Service a copy of the County Commission letter stating... On June 25, 2025, Deputy Meeks was administered a physical examination by Valley Health. On June 26, 2025, he was certified by a physician as capable of handling the prescribed duties of the rank of Corporal. This report will be located in the medical section of his personnel file kept at the Berkeley County Sheriff's Office. Deputy Meeks promotion was effective on June 26, 2025.
- (4) Based upon the information Mr. Alderton briefed, he recommend to the Commissioners a motion be made to close Item Number 2025 0020.

Commissioner Dopson made a motion to close Item Number 2025 - 0020. Commissioner Wilson seconded the motion. President Buck called for further discussion. There being none, he called for a vote. The vote was unanimous to close Item Number 2025 - 0020. **(CLOSED)**

- c. **Issue 2025-0023**, Request for Promotional Examination for the Rank of Corporal, as Result of the Resignation of Corporal Walker. The Eligibility date is May 4, 2025.
- (1) The promotional examination was conducted on Monday, June 16, 2025, in the training/classroom of the Berkeley County Sheriff's Office. Test materials were mailed back to WVDOP on June 16, 2025 at a cost of \$31.59.
- (2) Twenty-eight (28) deputies were eligible to participate in the promotional examination for the rank of Corporal. Of those, seven-teen (17) deputies completed the examination on Monday, June 16, 2025. Commissioner Dopson served as test proctor, along with Mr. Alderton.
 - (3) Test results were received, from WVDOP via email on June 24, 2025.
- (4) In accordance with the scoring formula outlined in the Berkeley County Deputy Sheriff Civil Service Commission (BCDSCSC) Rules and Regulations, the final scores were carefully and accurately calculated using Test Scores, Seniority & Evaluations scores by Commissioner D. Scott Wilson and Administrative Assistant John Alderton.
- (5) The names and total scores of the candidates were provided to the Commissioners in their Read-A-Head email.

- (6) On June 26, 2025 Chief Young sent an email stating Deputy Andrew Peck accepted the offer to be promoted to Corporal.
- (7) On Monday, June 30, 2025 Chief Young sent our office a letter stating... On June 30, 2025, Dep. Peck was administered a physical examination by Valley Health. On the same date, he was certified by a physician as capable of handling the prescribed duties of the rank of Corporal. This report will be located in the medical section of his personnel file kept at the Berkeley County Sheriff's Office.
 - (8) The effective date of the promotion is listed as June 30, 2025.
- (9) Based upon the previously stated information, Mr. Alderton briefed, he recommends to the Commissioners a motion be made to close this Issue Number of 2025-0023.

President Buck moved to close Item Number 2025 - 0023. Commissioner Wilson seconded the motion. President Buck called for further discussion. There being none, he called for a vote. The vote was unanimous to close Item Number 2025 - 0023. **(CLOSE)**

NOTE: Berkeley County Civil Service Certificates of Recognition were read into record and then handed over to Chief Young. The Certificates of Recognition were to recognize the Promotions of Corporal Meeks (See Attachment 2) and Corporal Peck (See Attachment 3).

- d. **Issue 2025-0026**, Request for New Open Hire Physical Agility & Written Examination RE: August 23, 2025.
- (1) As a reminder, it was briefed by Mr. Alderton the Commissioners made a motion last month, to set the date as Saturday, August 23, 2025, commencing at 9:00 AM. Martinsburg High School Athletic Director, has stated the time of 9:00 AM will not work.
- (2) Therefore, Mr. Alderton requested a motion be made by the Commissioners to change the start time from 9:00 AM to 8:00 AM.

Commissioner Wilson made a motion to amend the previous start time of 9:00 AM to 8:00 AM. Commissioner Dopson seconded the motion. President Buck called for further discussion. There being none, he called for a vote. The vote was unanimous to change the start time of the Saturday, August 23, 2025 Open Hire Physical Agility Test start time from 9:00 AM to 8:00 AM.

- (3) The topic turned to which Commissioner would be available to proctor the Physical Agility Test & Written Examination. Commissioner Wilson volunteered to serve as the test proctor for both.
- (4) The Online Application Process went LIVE on Monday, June 23, 2025. The Civil Service Commission is taking full advantage of technology working for us!!!!
- (5) As of Wednesday, July 16, 2025 thirty-seven (37) applications have been received. Of the 37 applications received, three (3) have been rejected due to: two (2) for drug related issues admitted on the application, one (1) for 4 moving violations within the past 24 months and one (1) withdrawal. We have six (6) applicants who have submitted ALL required documentation. Those six are now legible to test.
- (6) Mr. Alderton provided a little glimpse into the Online Application Process. He receives an email, stating an application is in the system. He reviews the application. Then he sends the applicant an email advising them their application has been "ACCEPTED". In the email, he advise them, to email him back three (3) required documents; (1) Medical Certification Form, (2) Notarized Signature Form and (3) Applicant Statement Signature Form, along with a copy (front & back) of their Driver's License, and if they're a Veteran to send him their DD214. The email advises them once, these documents are received by Mr. Alderton their status will be changed from ACCEPTED to "CANDIDATE" He also informs them, their status must be changed to CANDIDATE before they will be allowed to test on Saturday, August 23, 2025.
- (7) Mr. Alderton gave a brief snapshot of how the applicants learned of the openings. The following is a breakdown:

- Advertisement: 20

- Other: 8 - Friend: 3

- Employment Agency: 3

- Walk-in: 2 - Relative: 1

- (8) He added, the system does take a little bit getting used to. However, it's worth it!
- (9) Mr. Alderton wanted to highlight a very special thanks for Ms. Aleah Tucker, Executive Assistant to the County Commission. She has been amazing to work with getting us up and running. Mr. Chad Winebrenner, Deputy County Administrator has also been extremely instrumental in getting us up and running. **NOTE**: Mr. Alderton briefed the Commissioners, while he is out on vacation, Ms. Tucker is going to jump in and help out by accepting the applications. As well, as sending out Email notifications with associated required documentation for the applicants to complete.

 (OPEN)
- e. **Issue 2025-0028**, Request for Promotional Examination for the Rank of Corporal, as Result of the Promotion of Corporal Chronister to Sergeant on May 12, 2025. Eligibility date is May 13, 2025. Mr. Alderton provided the following update:
- (1) On May 12, 2025 Corporal Chronister was promoted to Sergeant. There by creating a vacancy for Corporal, with an effective date of May 13, 2025.
- (2) On June 4, 2025 Chief Young sent our office a letter requesting a promotional examination be offered for the rank of Corporal with an effective date of May 13, 2025.
- (3) As the result of the Commissioners not being able to proctor a test on the recommended date of Wednesday, July 9, 2025. The Commissioners voted to give sole discretion and authority to President Buck, as to selecting a test date, to be held at the Sheriff's Office.
- (4) The revised date provided was that of Friday, July 18, at 9:00 AM. Both President Buck and Commissioner Wilson, volunteered to proctor the test. It was decided Commissioner Wilson would serve as test proctor, as well as Mr. Alderton.
- (5) There were twenty-seven deputies eligible to test. We had fourteen (14) Deputies reply by the suspense date of Thursday, July 3, 2025 with their Letter of Intent to Test. Out of those 14, two members did email us ahead of the test date, stating they had a scheduling conflicts and would not be taking the test.
- (6) The test materials were inventoried on Friday, July 11, 2025, by myself, as witnessed by Lt Bill Christian of the Sheriff's Office. The test material were resealed and are to remain sealed until test time.
- (7) It was noted by Commissioner Wilson, this will be the first promotional examination given where study guides have been available.
- (8) Mr. Alderton requested of the Commissioners to provide those taking the test a survey to provide feedback for the commission and the West Virginia Division of Personnel who created the study guide. Commissioner's had no objection to a survey being created and provided to the deputies.
- (10) Commissioner Dopson raised a question. It was related to having two (2) promotions to Sergeant. He inquired if we filled those Corporal positions? Mr. Alderton,

explained one (1) was filled by Corporal Meeks and the other was filled by Corporal Peck. The test being offered on Friday, July 18, 2025 is to fill the vacancy as result of Corporal Chronister being promoted to Sergeant.

8. New Business:

- a. **Issue 2025-0030**, Application Revision for Deputy Sheriff to Coincide with Revised Rules and Regulations, Adopted June 18, 2025. President Buck, turned to Commissioner Wilson to address this issue.
- (1) Commissioner Wilson stated the whole intent was to make sure the application was in line with the commission's new rules and regulations. He made comment there really was not a lot of changes. It was more dealing with the drug related questions then anything.
- (2) He went on to say, what he did was list all the information and cited the particular Rules and Regulations as to where each item could be found. It was identified by President Buck the "revision date" on the application will need to be changed.
- (3) Mr. Alderton added that what the commissioners see, as far as cosmetics, the applicant does not see. As such, there is no "Revision Date" on the Online Application.
- (4) Commissioner Wilson stated he did add a little bit; such as Are you a Veteran? He added this, since there is a Veteran's Preference allowed by West Virginia State Code.
- (5) He added that on Page 2 its starts... Are you addicted to the habitual use of intoxicating liquors or drugs and there down. He started making a few changes to coincide with what the commission's new Rules and Regulations state. He added the references of the Rules and Regulations, so if anybody had any questions they know right where to go.
- (6) Commissioner Wilson is of the belief the application now brings it online with what the Commissions current Rules and Regulations stipulate.

President Buck inquired if there was a motion to adopt the revised application? Commissioner Dopson made a motion to adopt the new application, provided the application "Revision Date" is changed. Commissioner Wilson seconded the motion. President Buck called for further discussion. There being none, he called for a vote. The vote was unanimous to adopt the revised application (CLOSE)

9. Items from the Floor.

- a. Chief Burnett raised a question in regards to applications.
- (1) He stated, in speaking with some of the Sheriff's Office Staff & the Sheriff. When there's going to be an automatic disqualifier could they review that with Civil Service before they're disqualified, as another set of eyes?

- (2) President Buck stated he did not have a problem with that. However, the only concern he has. In what Mr. Alderton has been talking about is following the Rules and Regulations. To which Chief Burnett replied, the staff asked him to come and bring it up today.
- (3) Commissioner Wilson, then inquired of Chief Burnett, why? Chief Burnett responded just to make sure that something is not done by accident. Just to have two sets of eyes on it. Commissioner Wilson explained to Chief Burnett, before someone is rejected, there's at least Mr. Alderton and one of the three commissioners look at the issue before a rejection is made. It's not just Mr. Alderton making the decision. He reviews the application and brings it to a commissioner's attention. The Chief replied, oh you guys see it as well? Commissioner Wilson stated it's not just one person looking at it. Chief Burnett then replied, but since you guys are telling me that, I think we'll be fine. Again, Commissioner Wilson added, Mr. Alderton is not just looking at it. He sending it out to at least one of the three commissioners, if not all three of us, to look at it. Chief Burnett added, then we'll be fine with that.
- (4) Chief Burnett, then inquired out of curiosity why was the applicant with prior law enforcement experienced booted? Commissioner Wilson addressed the issue, as he was the one who reviewed the applicant's information and did some research. Basically, he was having some chronic pain. He went to a GNC and obtained a medication. Began using it. The police department held two (2) hearings. The owner of the GNC store testified and stated "We don't sell such a product. The applicant stated he got the stuff from him, that he didn't have a prescription for, as it's a schedule two narcotic. The police department dismissed him. He appealed it they gave him a second hearing. They dismissed him again. His dismissal was upheld.

10. **Announcements**. There were three (3) announcements.

- a. **Next Meeting**. Mr. Alderton announced, the next meeting of the Berkeley County Deputy Sheriff Civil Service Commission is scheduled for 5:00 PM, Wednesday, August 27: **NOTE**: Mr. Alderton highlighted the fact the next meeting would be held one (1) week later than the normal regularly scheduled meeting. He also noted, the yearly meeting schedule posted to the Civil Service Web Page (https://www.berkeleywv.org/DocumentCenter/View/11610/CSC-2025-Meeting-Schedule-PDF) was updated to reflect the change. Hopefully, the meeting can be held in the Commission Chambers. **NOTE**: Per Ms. Penny Shewell, the commission chambers cannot be reserved until the first day of every month. President buck inquired when would agenda items need to be submitted for next months meeting? Mr. Alderton replied all agenda items must be submitted by noon, on Thursday, August 21, 2025.
- b. The revised Rules and Regulations, which were adopted on Wednesday July, 16, 2025 have been posted to the Berkeley County Deputy Sheriff Civil Service Commission Web Page. The webpage may be viewed by going to https://www.berkeleywv.org/375/Civil-Service-Commission. Select Rules & Regulations on the left side of the screen.
