Previous Boards Minutes: June report: Motion by Mark Eisinger was made to approve the board minutes; Tracy Sherman seconded the motion, followed by a unanimous vote of "aye." Financial Reports: Mark Jordan provided an overview of the financial report, which included the balance sheet and P&L. Motion made by Mark Eisinger to approve the financial report with corrections, seconded by Tracy Sherman, followed by a unanimous vote of "aye."

Directors' Report: Mark Jordan provided the directors' report that included ICS and checking account information, Keydata reports on Airbnb/BRBO rentals, and the STR hotel report. Digital traffic continues to do well. Just completed a website audit, which resulted in a good rating with suggestions for some minor changes. Attend WVACVB meetings and the WV Filmmakers Guild Meetup. Assisted the WV Film Office with contact information for hotel stays for visiting film producers. Discussed the recent visits with travel writers and a follow-up meeting to discuss upcoming visits from travel writers to the area. Mark also discussed a recent interview with

WVTim, featuring a podcaster from WVNPR. Mark also discussed a few organizations that were coming to the area soon for meetings, such as WV Executive, and Shenandoah Valley Battlefields National Historic District's 2026 National Civil War Conference and the Martinsburg Apollo Film Festival.
